ITEM	TOPIC/DISCUSSION
1	A copy of the meeting's PowerPoint presentation is attached to this meeting summary.
2	Mindy Peterson (Parsons) discussed the purpose of the EJ Meeting and welcomed the group.
3	Mindy (Parsons) discussed the role of EJ members.
4	It was requested that future meetings maintain a hybrid option. Most attendees favored morning meetings.
5	Mindy (Parsons) provided an overview of the Link 101 project, noting it is an Indiana Department of Transportation (INDOT) project examining an improved SR 101 connection between the Markland Dam and US 50. The SR 101 extension is expected to provide more direct access to I-71 and US 50. The project area includes portions of Switzerland, Ohio, Dearborn and Ripley counties. Environmental analysis and

	preliminary design work are underway. The project will determine the Purpose and Need – the "why" – for the project. The process of identifying a selected alternative is expected to take about three years.
6	Mindy (Parsons) discussed that the Project Team is holding meetings with stakeholder committees, launching the project website, holding a public meeting and opening the project office. Gathering input to help identify project needs is an important part of public involvement. Selecting an alternative is a prescribed, iterative process that starts with very general routes. After broad routes are developed, alternatives will emerge to be studied in greater detail. A preferred alternative that meets the Purpose and Need comes from detailed analysis. Environmental Justice (EJ) is an important part of the project process. Environmental Justice seeks to ensure the fair treatment of all people regardless of race, color, national origin, or income with respect to the development of projects and investment of resources.
8	Dan (Parsons) outlined a set of questions designed to initiate discussion.
9	Mindy (Parsons) discussed next steps. The draft environmental document is expected in fall 2024. A public hearing and formal comment period will be held. Two public meetings will be held next week. The in-person meeting is January 18 at Dillsboro Elementary, 5:30 to 7 pm with a 6 pm presentation. A virtual meeting is planned for January 19 at 6 pm. A registration link was provided. CAC members were encouraged to share the public meeting information with their groups and interested parties. Meeting fliers were shared electronically with CAC members and printed copies were available at the meeting.
10	Mindy (Parsons) shared that project social media channels and the website will launch January 18. The project website, Link101Corridor.com has project information, FAQs, maps and more. CAC and public meeting materials will be posted there. Sign up for project updates via email (on the project website or text (text "INDOT LINK101" to 468311). Project contact channels are used with all feedback shared with the Project Team. The Project Office is in the Switzerland County Technology and Education Center, 2nd floor. The office opens Monday, January 23 and will be open Mondays and Wednesdays from 10 a.m. to 3 p.m. and by appointment. 11	The presentation was collaborative with discussion with members throughout.
12	Erin Thomas (LifeTime Resources) made the following comments:
	Catch a Ride is a rural public transportation system in six counties.
	• The majority of current travel with Catch a Ride is for work and the elderly going to medical appointments and to get groceries.
	• Pay particular attention to the relocation of elderly adults and the disruption to their lives.
	Most LifeTime Resources trips are 10 miles or less.
	There is a Park and Ride facility in Decatur County.
	LifeTime Resources is looking for options to connect people to Cincinnati.
	• Check with large employers in the area to get a better sense of who is using Park and Ride facilities and to establish a connection point with these drivers.
	Consider farming areas.
	Consider Amish populations in relation to both property and transportation needs.
13	Paula Brooks (Hoosier Environmental Group) asked if bicycle lanes would be considered and noted adequate shoulders should be included for cyclists. Safety is currently an issue. Andy Dietrick (INDOT)

SRIUTCO	indicated the Project Team will look at communities in the area, existing trails and plans for trails. Promoting healthy choices is important.	
14	Erin (LifeTime Resources) asked if electric vehicles and future charging stations are being considered. Dan (Parsons) noted EV stations in the project area are not part of this project.	
15	Erin (LifeTime Resources) noted with a trip from Vevay to Dillsboro, there's no good way to get there. It's also not a good road for transit because it's curvy, etc.	
16	Erin (LifeTime Resources) said work is underway on a regional plan for connectivity to Cincinnati.	
17	Paula (Hoosier Environmental Group) asked if there were a lot of seasonal workers at farms. Erin (LifeTime Resources) said no.	
18	Paula (Hoosier Environmental Group) asked whether a road offering better connections to I-71 and I-74 will result in traffic bypassing Vevay. Dan (Parsons) noted routes have not yet been determined.	
19	Erin (LifeTime Resources) suggested signage for attractions and meeting with tourism directors.	
20	It was noted there was concern about bypassing Vevay with a new roadway – signage could mitigate those issues.	
21	It was noted there is often no single destination for drivers in the area – often travel to Lawrenceburg, Batesville, etc.	
22	It was noted the Swiss Wine Festival brings a crowd from the region.	
23	Pam Acton (Vevay – Switzerland County Foundation) made the following comments:	
	• It's important that SE Indiana feel acknowledged and see this investment to better connect with the state.	
	• The local radio station has local programming in the morning and is an opportunity for outreach. Adam Griffin is the contact.	
	• Social media is also a great resource. Local tourism sites have a strong following.	
	 Reach out to high schools. Buses and parents traveling winding roads in the dark, especially for sports. 	
	• The United Way is now in Jefferson County but doesn't appear to be active in the area.	
24	Kari Carmany-George (FHWA) asked about internet connectivity in the area. Pam (Vevay – Switzerland County Foundation) indicated connectivity is improving and broadband is being run. REMC will install if requested. Verizon cell connectivity is the strongest.	
25	Pam (Vevay – Switzerland County Foundation) suggested several contacts for community outreach:	
	Adam Griffin at local radio station (Froggy 95.9), local programming in the morning.	
	• Pat Lanman owns Vevay newspapers. He's also the minster at Olive Branch Baptist Church, which has a large congregation.

	• Tye Sullivan for Lions Club, other groups and regular e-blast to non-profits.








- A timeline for construction will be determined at the end of the environmental study.












PROJECT HISTORY

- INDOT studied SR 101 in 2003 to assess limited north-south access and identify feasible improvement alternatives
- Improving safety, reducing crashes, and improving regional accessibility and connectivity were key transportation study needs


